Rite Brothers.



ON MAY 18, 2017, The Scottish Rite Education Committee met to interview candidates for The John W. Brockman Fellowship. The purpose of this Fellowship is to identify and provide monetary awards to graduate students in Maryland universities who are preparing to become speech and language therapists. All award recipients are required to serve one semester of their supervised clinical practice in our own Hilgenberg Childhood Center for Speech and Language Disorders. This Fellowship has been awarded to over 90 students since it was established in 1982.

This year, the committee interviewed four candidates from Loyola University and

Towson University. Awards totaling \$4,000 were made to Sarah Morrison from Towson University and Amanda Puglise from Loyola University. The committee is pleased to announce The Brockman fellows for 2017.

Meredith Chapter of Rose Croix

their summer and are ready to resume our Scottish Rite activities this fall. We will be conferring two of the four Chapter degrees this upcoming fall: *Knight of the East, and Knight Rose Croix*. The Chapter degrees not only convey important truths, they each have a rich history that can sometimes be as interesting as their content. These degrees all descend from earlier forms that existed in the mid-18th century.

A degree that is scheduled to be conferred this fall is the Knight of the East and an early version of this ritual was first published in 1766 in a French book titled Les Plus Secrets Mystéres des Hauts Grades de la Maçonnerie Dévoilés (The Most Secret Mysteries of the High Degrees of Masonry Unveiled). The degree in this book was called Knight of the Sword and of the Rose-Croix and corresponds with the *Knight* of the East (15°) and Princes of *Jerusalem* (16°) of the modern Ancient and Accepted Scottish

Rite. According to the Ill. Albert Mackey, 33°, a version of the 15th degree of the Scottish Rite is "found in all the Rites and systems which refer to the second Temple." These degrees perpetuate the theme of workmen holding a sword in one hand to fend off enemies while holding a trowel in the other working to rebuild the Temple. The principal lesson of the 15° is to persevere through difficulties in order to successfully achieve one's goals. And the 16th degree furthers this lesson by teaching that God will help us overcome these difficulties if we are faithful, wise, and pursue good works.

The degree of *Knight of the East and West* (17°) is the first philosophical degree of our Rite and makes use of the religious sect known as the Essenes. It was their belief that Truth is dispersed throughout the world in different belief systems. It is the duty of each Mason to discern the divine Truth scattered throughout the

Orient (East) and the Occident (West) and combine them into a coherent whole to guide mankind through life. This degree also comes to us from the same time period as the other Chapter degrees, even though early forms of this degree profess to date from 1118.

The Chapter concludes with one of the most well-known high degrees, the Knight Rose Croix (18°), and is one of my favorite degrees in Masonry. References to this degree are found as early as 1747 and it has been an important degree in several rites that have existed over the last few centuries, including the Ancient and Accepted Scottish Rite. The Ill. Albert Pike, 33° tells us that this degree "teaches three things;—the unity, immutability and goodness of God; the immortality of the Soul; and the ultimate defeat and extinction of evil and wrong and sorrow..." Not only does it impart worthy teachings but, this is a very mystical degree and is filled with rich symbolism.

There is so much more to these degrees that cannot be conveyed in a short article, so I hope that you will come out to the conferrals of the 15° and 18° this fall. The date for the Knight of the East is scheduled for October 25 and the Knight Rose Croix is scheduled to occur November 1.

How We Bring Members into the Fraternity is Far Less Important Than What We Do with Them Afterwards

You gotta be kidding. Me? Attend Lodge? No way!

"I'd rather have a root canal then go down and listen to those guys waste my time opening, reading the minutes, reviewing bills, closing, and then having to face lukewarm coffee and store-bought pie before I can go home."

Sound familiar? You can even add your own particular anecdote about why Masons don't attend lodge. But they all come out the same; Freemasons would rather do almost anything than go to lodge. We have made "lodge night" the least important date in our calendar.

So, why are we now staying away in droves?

First of all, we have to realize that staying away from lodge is not a recent phenomenon. Just for example, in the 1940s and 50s, when Carl Claudy wrote his series of plays, he did it, primarily, to stimulate lodge interest and attendance. In reading early Masonic publications such as The Master Mason or The Builder, we also find that a great concern was the definite lack of interest in attending lodge.

Perhaps, at this point, we ought to define the term lodge:

Coil's Masonic Encyclopedia says: The lodge has always, from the earliest times to the present, been the center of Masonic activity and interest. Both the lodge and the Fraternity have changed over the years and the name, lodge, has taken on several different meanings, but the essential relation of the lodge to the whole organization has remained constant. It is still the basic assembly, the place where Masons are made, where they meet, and where they work.

My own personal definition:

The Lodge is our oasis. A place where we go to be refreshed and take what we learn back into the world.

It is also extremely important to know that I am not defining lodge as a building Location, but rather, as a place to experience spiritual, emotional, educational, and creative opportunities that enrich not only our own lives but also the lives of those with whom we come in contact.

Spiritual: Because every lodge is God centered.

Emotional: Because we derive happiness from making new Masons and contributing to many charitable activities.

Educational: Because we learn from our ritual and lectures and charges.

Creative: Because we are encouraged to think and put our ideas to work.

The place where all these things come together is lodge. The lodge is the center of our Masonic universe.

How are today's Lodges perceived?

Remember those Brothers who used to say. I became a Freemason because I watched all of the men in town that I respected going upstairs and through the door into a room. I didn't know what they were doing, but I knew those men, and I knew I wanted to be part of that group.

Those men were going to lodge and it was noticed. You don't hear that kind of statement very much anymore, and I know there are many reasons. For one thing, lodges are much larger. If you have a membership of 20 to 50, everybody knows each other, but when you start getting into the hundreds, then you tend to lose close person-to-person contact. And, I know that we are a transient society moving about constantly. Just a few generations ago, we seldom moved from the town in which we were born, and then our move was usually only somewhere else in the same county. Nowadays, people tend to move on before you get a chance to really know them.

Reading Masons and Masons Who Do Not Read

I SUPPOSE THERE are more Masons who are ignorant of all the principles of Freemasonry than there are men of any other class who are chargeable with the like ignorance of their own profession, There is not a watchmaker who does not know something about the elements of horology, nor is there a blacksmith who is altogether unacquainted with the properties of red-hot iron. Ascending to the higher walks of science, we would be much astonished to meet with a lawyer who was ignorant of the elements of jurisprudence, or a physician who had never read a treatise on pathology, or a clergyman who knew nothing whatever of theology. Nevertheless, nothing is more common than to encounter Freemasons who are in utter darkness as to everything that relates to Freemasonry. They are ignorant of its history they know not whether it is a mushroom production of today, or whether it goes back to remote ages for its origin. They have no comprehension of the esoteric meaning of its symbols or its ceremonies, and are hardly at home in its modes of recognition. And yet nothing is more common than to find such sciolists in the possession of high degrees and sometimes honored with elevated affairs in the Order, present at the meetings of lodges and chapters, intermeddling with the proceedings, taking an active part in all discussions and pertinaciously maintaining heterodox opinions in opposition to the judgment of brethren of far greater knowledge.

Why, it may well be asked, should such things be? Why, in Masonry alone, should there be so much ignorance and so much presumption? If I ask a cobbler to make me a pair of boots, he tells me that he only mends and patches, and that he has not Iearned the higher branches of his craft, and then honestly declines the offered job. If I request a watchmaker to construct a mainspring for my chronometer, he answers that he cannot do it, that he has never learned how to make mainsprings, which belongs to a higher branch of the business, but that if I will bring him a spring ready made, he will insert it in my timepiece, because that he knows how to do. If I go to an artist with an order to paint me an historical picture, he will tell me that it is beyond his capacity, that he has never studied nor practiced the

comportion of details, but has confined himself to the painting of portraits. Were he dishonest and presumptuous he would take my order and instead of a picture give me a daub.

It is the Freemason alone who wants this modesty. He is too apt to think that the obligation not only makes him a Mason, but a learned Mason at the same time. He too often imagines that the mystical ceremonies which induct him into the Order are all that are necessary to make him cognizant of its principles. There are some Christian sects who believe that the water of baptism at once washes away all sin, past and prospective. So there are some Masons who think that the mere act of initiation is at once followed by an influx of all Masonic knowledge. They need no further study or research. All that they require to know has already been received by a sort of intuitive process.

The great body of Masons may be divided into three classes. The first consists of those who made their application for initiation not from a desire for knowledge, but from some accidental motive, not always honorable. Such men have been led to seek reception either because it was likely, in their opinion, to facilitate their business operations, or to advance their political prospects, or in some other way to personally benefit them.





A History of Granite Lodge #177

403 St. Mary's Square, St. Michaels, MD. | Meets the First & Third Wednesdays Worshipful Master – RW Brother Michael E. Holcomb

GRANITE LODGE NO. 177. located in St. Michael's, Maryland, was Chartered on May 11th, 1881. Granite Lodge was preceded by Burns Lodge No. 87, which was originally chartered in Trappe, Maryland in 1845, Burns Lodge relocated to the town of St. Michael's in 1863 but was eventually closed in 1874. There was a meeting held on November 10th 1880 for the purpose of forming a new lodge. A decision was made to name the new lodge Granite Lodge. On November 15th, 1880, Coats Lodge No. 102, located in Easton, Maryland, was given a petition requesting a Warrant to operate under dispensation from the Grand Lodge of Maryland. With the support of Coats Lodge, the Grand Lodge approved this petition from Granite Lodge for the purpose of obtaining a Charter which was granted to them on May 11th, 1881. For many years, the Lodge met in different buildings, eventually finding a permanent building in 1931. The present building is a former Methodist Church that was built in 1839 located on St Mary's Square in St Michael's, Maryland. The site was also the location of an earlier Church that was built in 1781 when the town was first being laid out by James Braddock, a representative of James Gildart and John Gawith & Company, a merchant firm from Liverpool England. The land was donated to the Society

of People called Methodists and they were given two lots "in order that they may and shall build thereon a good and convenient house for the public worship of Almighty God."

MW Brother B. Hope Harrison was Worshipful Master of Granite Lodge #177 in 1971 and 1979 and served as Grand Master of Masons in Maryland from 1988 to 1990.

Today, Granite Lodge No. 177 flourishes with renewed membership and continues the work of spreading the cement of Brotherly Love, Relief and Truth and continues to grow our Maryland Masonic Family.

at those locations. Brother Matthew Sanders, Worshipful Master and his officers rededicated the cornerstone at the temple on West Church Street.


The best men of the community have been members of the Craft and have always deemed it an honor to be listed among our members, which included Ministers of the Gospel of all denominations,
