

I would urge our brethren to ask this informed historian to share with them some of the historical facts that make this cooperation so exceptional in Maryland. 

"But come, ye sons of Liberty


Columbia's offspring, brave as free.

Nekam Adonai or "Vengeance is Thine, O Lord"

THIS IS A STRANGE MOTTO to consider for our 30th degree. What is its meaning? When we consider that the Hebrew word *kadosh* translates to holy or consecrated, why would our Knight Kadosh or Holy Knight Degree have us contemplate vengeance, of all things?

I think we need to start at the beginning: a trio of skulls and the admonition, "You now hold your fate in your own hands." We start with the three skulls in the center representing De Molay, or the last Grand Master of the Templars (wreathed in laurel and amaranth). To De Molay's left is a crowned skull representing King Philip the Fair, and to the Grand Master's right is a skull representing Pope Clement. De Molay was a martyr of truth burned on a pyre by the king, representing the tyranny of the despot and the Pope representing the ambition of unholy religious leaders. This is not a political statement, but when combined

with the ladder of Kadosh, a lesson and a framework that can be applied to the unique responsibility and possibility of interacting rationally and compassionately with the world.

When I hear the candidate being admonished that he holds his fate in his own hands in the first apartment, I am led to believe that De Molay is a metaphor for the candidate living in civil society surrounded by the possibility of tyranny, be that in the form of the government, king, or religion. In the second apartment, we are reminded that the modern knight does not fight the same battles as De Molay, but rather fights against oppression, injustice, and usurpation, and internally fights his own ignorance, prejudice, and error. The third apartment highlights that this path of a knight is not easy. As we pass through the degree, our attention is brought to the ladder of Kadosh; it is in this fourth apartment that we are given a framework.

This mysterious ladder of Kadosh is a means to frame our interaction with a world full of intellectual and emotional adversity. It may, at first glance, appear very esoteric, but it is actually a methodology. Like the seven steps of the liberal arts and sciences in our Fellowcraft degree, one half of this

ladder has one rung for each of the liberal arts and sciences. On the other side, the staves of the ladder have written on them "Love of God" and "Love of Neighbor," with each rung written: Justice, perfect equity, amiability, good faith, great labor, endurance, and understanding.

What does this mean? To me, one side gives me a framework to understand the physical world, and the other gives me a guide for empathizing with the citizens of the world. If we start with the motto, let's close with a look at the prayer that asks God to help us "to remove obstacles which tyranny and imposture interpose between man and happiness, between man and knowledge." The ladder is the framework that helps the Knight Kadosh in the pursuit of happiness and knowledge. The motto is a reminder that vengeance is the Lord's to repay, admonishing the Knight not to lose sight of this and fall into the trap of persecuting the persecutors, meeting intolerance with intolerance. In our polarized world of today, our 30th degree has lessons for us yet.

Sadly, too many have lost the ideals and values that those soldiers stood for and died defending. Today, we all have encountered some of the ignorance and careless attitude plaguing our country.



A Word from Dr. Albert G. Mackey, 33°

By: Albert G. Mackey, 33° March 12, 1807 – June 20, 1881

MEN WHO THUS MISCONCEIVE the true policy of our Institution, should be instructed by their older and more experienced brethren that it is wholly in opposition to all our laws and principles to ask anyone to become a Freemason, or to exercise any kind of influence upon the minds of others, except that of a truly Masonic life and a practical exemplification of the tenets by which they may be induced to ask admission into our Lodges. We must not seek—we are to be sought.

And if this were not an ancient law, imbedded in the very cement that upholds our system, policy alone would dictate an adherence to the voluntary usage. We need not now fear that our Institution will suffer from a deficiency of members. Our greater dread should be that, in its rapid extension, less care may be given to the selection of candidates than the interests and welfare of the Order demand. There can, therefore, be no excuse for the practice of persuading candidates, but every hope of safety in avoiding such a practice.

PROCEEDINGS, GRAND LODGE OF MARYLAND, 1857, PAGE 35

The evil influences exerted by these societies on our Institution have frequently attracted attention. The Grand Inspectors for the city of Baltimore, in the Grand Lodge of Maryland, make on this subject the following remarks: "Many are crowding into our Institution from other secret societies, having their prejudices and peculiar ideas and notions, with a disposition to make Masonry conform to what they have been taught elsewhere; and finding places of power and honor easy of access, are hardly sensible of the burdens imposed upon Entered Apprentices, or conscious of what material is necessary for the building, before they are superintending, as Masters, its construction, and sometimes seem indignant that they should be told they are spoiling the temple."








SCOTTISH RITE MASONRY IN MARYLAND

Excerpt from: Gould's History of Freemasonry throughout the World



A LODGE OF PERFECTION was instituted at Baltimore on December 21, 1792, by Illustrious Bro. Henry Wilmans, Grand Inspector General of the Rite, who later became Grand Master of Masons of Maryland. As to the source of his powers, nothing can be ascertained. Since the signatures of 76 of the most prominent Brethren of our State appear on the Constitution and Laws 304 FREEMASONRY IN MARYLAND of the Baltimore Body, the inference is clear that in those days it must have been a very living creation. Unfortunately, no records or other documents remain. The only reference to this Body that has been discovered is in the Proceedings of Concordia Lodge, under date of 1804. There it is recorded that "the sum of \$150 was paid on account of the Sublime Lodge."

At about the time this Lodge of Perfection was formed, another Body of the High Degrees was established in Baltimore. That was Rose Croix
Chapter La Verite,
which was brought
to Baltimore between 1791 and
1793 by French
Brethren who were
refugees from San
Domingo. The Rite
worked by those
Brethren consisted
of seven degrees.
The Rose Croix
Degree was the
highest, it being

the 18th Degree of the Rite of Perfection as well as the 18th Degree of the Ancient Accepted Scottish Rite. That was called the French or Modern Rite. In the expressive language of the French Brethren, this Body went to sleep about the year 1800. In 1919, however, it was aroused by Louis Leloup, Grand Inspector of the Grand Consistory of Chiefs of Exalted Masonry of New York, and revived under the distinctive title, Triple Unity Lodge. In the following year, that Lodge received a Charter from the Grand Consistory of New York. Portions of the Chapter Records, written in French, still exist. From them we learn that on October 19, 1819, John Laborde, Pere Lanney, and Louis Leloup, ancient members of Chapter La Verite established at Baltimore about 1791, conferred the Degrees upon nine Brethren who then formed a "Chapter Provisionary" and subsequently obtained the Charter referred to above.

The Chapter was duly constituted on September 21, 1820, and the Officers were Installed by Louis Leloup, Deputy Grand Inspector. Regulations for the government of the Chapter consisted of twenty Articles. Degrees from the 4th Degree to the 18th Degree were divided into six classes, fees for the whole being fifty dollars. Thirty-two signatures are subscribed to the document, among them those of many prominent members of the Craft.

The Grand Consistory at New York also issued a Charter, consisting of three closely printed pages and bearing the same date as that on the Chapter Charter, to a number of Brethren already mentioned in this article. That Charter empowered them to erect a Grand Council of Princes of the Royal Secret at Baltimore. Records and other documents still in existence are clear evidence that both the Chapter and the Council were active Working Bodies. With the close of the year 1826, however, no further records seem to have been kept, and consequently nothing is now known about the activities of either Chapter or Council after that date.

(of the Regis Poem 1390)

THE FIFTEEN ARTICLES

- 1. The Master must be steadfast, trusty and true; provide victuals for his men, and pay their wages punctually.* *This reference to the wages of operative Masonry is still preserved in the formula of the Senior Warden's response in opening and closing a Lodge; but the wages of a speculative Mason consist in a knowledge of truth.
- 2. Every Master shall attend the Grand Lodge when duly summoned, unless he have a good and reasonable excuse.
- 3. No Master shall take an Apprentice for less than seven years.
- 4. The son of a bondman shall not be admitted as an Apprentice, lest, when he is introduced into the Lodge, any of the brethren should be offended.
- 5. A candidate must be without blemish, and have the full and proper use of his limbs; for a maimed man can do the craft no good.
- 6. The Master shall take special care, in the admission of an Apprentice, that he do his lord no prejudice.

Speculatively, no candidate shall pass to a higher degree, until he has served a "sufficient time" and made "due proficiency" in the preceding degree.

- (This is repeated in all subsequent regulations, and is still in force notwithstanding some recent attempts to reduce its rigor.)
- 7. He shall harbor no thief or thief's retainer, lest the craft should come to shame.
- 8. If he unknowingly employ an imperfect man, he shall discharge him from the work when his inability is discovered.
- 9. No Master shall undertake a work that he is not able to finish to his lord's profit and the credit of his Lodge.
- 10. A brother shall not supplant his fellow in the work unless he be incapable of doing it himself; for then he may lawfully finish it, that pleasure and profit may be the mutual result.
- 11. A Mason shall not be obliged to work after the sun has set in the west.
- 12. Nor shall he decry the work of a brother or fellow, but shall deal honestly and truly by him, under a penalty of not less than ten pounds.
- 13. The Master shall instruct his Apprentice faithfully, and make him a perfect workman.
- 14. He shall teach him all the secrets of his trade.
- 15. And shall guard him against the commission of perjury, and all other offences by which the craft may be brought to shame.

THE FIFTEEN POINTS

- 1. Every Mason shall cultivate brotherly love and the love of God, and frequent holy church.
- 2. The workman shall labor diligently on work days, that he may deserve his holidays.
- 3. Every Apprentice shall keep his Master's counsel, and not betray the secrets of his Lodge.
- 4. No man shall be false to the craft, or entertain a prejudice against his Master or Fellows.
- 5. Every workman shall receive his wages meekly, and without scruple; and should the Master think proper to dismiss him from the work, he shall have due notice of the same.
- 6. If any dispute arise among the brethren, it shall be settled on a holiday, that the work be not neglected, and God's law fulfilled.
- 7. No Mason shall debauch, or have carnal knowledge of the wife, daughter, or concubine of his Master or Fellows.
- 8. He shall be true to his Master, and a just mediator in all disputes or quarrels.
- 9. The Steward shall provide good cheer against the hour of refreshment, and each Fellow shall punctually defray his share of the reckoning, the Steward rendering a true and correct account.

10. If a Mason live amiss, or slander his Brother, so as to bring the craft to shame, he shall have no further maintenance among the brethren, but shall be summoned to the next Grand Lodge; and if he refuse to appear, he shall be expelled.

- 11. If a Brother see his Fellow hewing a stone, and likely to spoil it by unskillful workmanship, he shall teach him to amend it, with fair words and brotherly speeches.
- 12. The General Assembly, or Grand Lodge, shall consist of Masters and Fellows, Lords, Knights and Squires, Mayor and Sheriff, to make new laws, and to confirm old ones when necessary.
- 13. Every Brother shall swear fealty, and if he violate his oath, he shall not be succored or assisted by any of the Fraternity.
- 14. He shall make oath to keep secrets, to be steadfast and true to all the ordinances of the Grand Lodge, to the King and Holy Church, and to all the several Points herein specified.
- 15. And if any Brother break his oath, he shall be committed to prison, and forfeit his goods and chattels to the King.

MAUNDY THURSDAY DINNER — Why We Meet This Day Thursday, April 5th, 2012

The most logical reason is to rededicate ourselves, but to be more explicit, this meeting on Maundy Thursday for the Hebrew is in commemoration of Passover, a great religious feast celebrated by the Jews on the thirteenth day of their calendar month Nisan, for their release from slavery in Egypt. For the Christian, the meeting on Maundy Thursday is in remembrance of the last supper of our Lord, which was on Holy Thursday nearly 2,000 years ago.

From these meetings on Maundy Thursday, let the vivid impressions bring humility and good deeds to the exhibit of Masonry, rededicating ourselves to the labors of Masonry. This task is not easy, but it has meaning and influences young people, the leaders of tomorrow. This task can be pleasant and enjoyable, for his life is as broad as its love and service, as high as its ideals and as deep as its convictions.

The Symbols of the Mystic Banquet

- The Matzo, or unleavened bread, is also called bread of affliction. It is symbolic of the bread which
 the Hebrews made when they hastily left Egypt, because they did not have enough time to allow
 their dough to rise. The Matzo is the most important symbol of Passover.
- 2. **The Moror**, or bitter herb (represented by a small slice of horseradish), is symbolic of the hardships which the Israelites endured while they were slaves in Egypt.
- 3. **The Haroses**, a paste of apples, nuts, spices and wine, is symbolic of the mortar the Israelites used when they were slaves, in the construction of the Pharaoh's treasure cities, Pithom and Ramses.
- 4. **The Shank Bone**, a roasted bone, is symbolic of the Paschal Lamb that was sacrificed and eaten on the eve of Passover.
- 5. The Hard-Boiled Egg is symbolic of life and spring time, when nature renews life.
- 6. **The Four Cups of Wine** commemorate the four promises made by God to Moses to redeem the Israelites and bring them out of bondage.
