


## REBUILDING FOR FUTURE GENERATIONS A MESSAGE FROM

**GREETINGS ONE AND ALL!** I hope this winter has been kind to each of you and you are ready for the warm rays of a spring sun. Spring is a time for new growth and rebuilding from the cold, harsh winter.

When you look at the cover of this issue of the “Rite News” and the Scottish Rite Journal, what are your first thoughts? Are they about remodeling the Temples, or what beautiful completed edifices they are? Did you give any thought to rebuilding or strengthening our membership in our gentle fraternity? Any of these thoughts would be appropriate for the situation we find ourselves in today. Both of our gorgeous Temples in Baltimore and Washington D.C. were designed by the famous John Russell Pope, who also designed the Jefferson Memorial, the Baltimore Museum of Art, the National Art Gallery and many other notable structures. These superior masterpieces, built in 1915 and 1930, are rapidly approaching 100 years old. And as with everything and everyone that ages, they require regular care and maintenance.

Hold on, don’t stop reading! This is not another plea for much needed money. It is just food for thought.

Have you considered the age of our fraternity? Our membership began in the United States around 1801. That is over 200 years of weathering the storms of war, depression, civil uprisings and non-conformity. Our membership numbers, like our Temples, are starting to reflect the effects of time. They both need attention and maintenance in order to survive.

Our Grand Commander Ill. Ronald A. Seale and our Most Worshipful Grand Master Ill. Stephen J. Ponzillo, III both recognize that *now* is the time for action. Long overdue alterations must be made to our Temples as well as the manner in which we attract and maintain our membership. Both will require time, effort and money, but most of all, our personal commitment.

MWGM Ponzillo, by vote of the Grand Lodge, has launched an advertising campaign that, to date, has produced some very positive results. In fact, this campaign could produce petitions that greatly outnumber those from last year. That is tremendous news, not

only for our Blue Lodges but for every collateral body in Maryland that will reach out and offer these new men a second home. Many of these men are young with new ideas and skills that our lodges and collateral bodies can utilize. All we need to do is reach out to them and make each feel welcome and, at the same time, stress the importance of supporting their Blue Lodge.

The Scottish Rite has much to offer to a Master Mason who has a quest for further knowledge. Not only do we offer 29 degrees that have a deep, rich meaning and encourage the true tenants of brotherly love, relief and truth, we also offer an excellent educational program. It is designed for either self-study or group sessions. ### Spring One-Day Class in Honor of Ill. William W. Mangels, 33°—1922–2010



William Wendilyn Mangels was born on August 12, 1922 in Baltimore, MD to Henry and Anna Mangels. He attended Baltimore City schools as well as vocational school. In 1947, Brother Mangels began working for the National Brewing Company, where he worked for 38 years, retiring in 1985.

Brother Mangels was a Seaman First Class in the U.S. Maritime Service, and was on active duty from June 1944 until October 1945, when he was honorably discharged.

Brother Mangels was initiated in Patapsco Lodge #183 in January 1969 and was raised to the Sublime Degree of Master Mason on September 4, 1969. He joined the Scottish Rite in the Fall Class of 1970. He served as Master of the Robing Room at the Scottish Rite for many years. Brother Mangels received his KCCH in October of 1975 and was coroneted a 33°, Inspector General Honorary in November of 1985.

In addition to the Scottish Rite, he was active in the Tall Cedars as well as Boumi Shrine, where he was in the Boumi Drum Corps (this is where he received the nickname "Uncle Puffer").

Brother Mangels is survived by his wife of 68 years, Margaret, as well as one child, three grandchildren, eight great-grandchildren and two great-great grandchildren.



## Cumberland Scottish Rite Language Disorder Clinic Fund Raiser

MEMBERS OF THE RETIREMENT CLUB of the Cumberland Scottish Rite recently completed a successful "Buck-A-Cup" fundraiser in support of the Scottish Rite Childhood Language Disorder Clinic in Cumberland, Maryland. The clinic is managed by the League for Crippled Children, Inc., located at the Allegany County Health Department, Willowbrook Road, Cumberland, MD. Co-chairmen for the event were Curtis Haines, 32°, KCCH and Kenneth Wilson, 32°, Scottish Rite Retirement Club.

The Buck-A-Cup program was held November 1 through December 4 throughout the tri-state area.

Area restaurants encouraged their servers to distribute cards or pins for a "one buck" donation. The donation entitled the customer to receive free coffee or tea on December 3 and 4 at any of the participating restaurants.

An appreciation and awards luncheon will be held February 1 at 2pm at Arby's, National Highway, LaVale, MD. The luncheon is open to everyone who participated in the fundraiser. Awards will be presented to the winning restaurants and servers.
